The following details are answers to frequently asked questions...

Set-up & Security

Set-up is available two days before the start date of the show and must be completed by the first day of showing. For the safety of our riders and horses, vendor spaces may not be set-up or torn down while horses are competing. Security of your booth is your responsibility. We are not responsible for the loss, theft or damage to any vendor space, merchandise or loss of profit.

Space Assignment

Each vendor has been assigned a space according to the space selection you checked on the agreement. There will be a vendor chart in the show office. Ask for Sheri Bridges if you have a question about where your vendor spot is located. Your vendor fee includes one table. If additional tables are needed, indicate on vendor contract.
